In order to perform our duty as the administrator of your personal data within the meaning of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter referred to as: "GDPR") we hereby inform you that:

- 1. The administrator of your personal data provided by means of the application form of the Rafał Brzoska Foundation Scholarship Fund's scholarship programme ("the Programme") is the Rafał Brzoska Foundation with its seat in Warsaw at the following address: ul. U2, 02-646 Warsaw, entered into the Register of Associations, Other Social and Professional Organisations, Foundations and Public Healthcare Facilities by the District Court for the Capital City of Warsaw, 13th Economic Department of the National Court Register, under the KRS number: 0000972080, NIP: 5213970707, REGON: 522187187 (hereinafter referred to as "the Administrator" or "the Foundation").

- 3. The candidates' and the Programme participants' as well as their parents' / legal guardians' data are processed for the following purposes:

- a. conducting the recruitment process and executing the Programme in accordance with the 2024 Rafał Brzoska Foundation Scholarship Fund Competition Regulations;
- b. contacting the candidates as well as defending, managing and pursuing mutual claims, should such arise;
- c. performing legal duties, including the duties imposed by tax laws.
